ORDER

1. Disciplinary action under AIS (D&A) rules was initiated against Shri, Jupudi Prasad, IFS (KL; 1983) formerly Divisional Forest Officer. Malayatoor for the irregularities in the repairs of tribal House under Thalumkandom Tribal Colony ion Edamalayar Forest Station of Thundathil Range in Malayatoor Forest Division and Articles of charge and statement of imputations were served on the officer a per the reference first read above. In his written statement of defense the officer has denied the charges framed against him. Government after considering the written statement of defense of the officer, have decided to conduct a detailed enquiry into the charges as contemplated in Rule 8 of AIS (D&A) Rules 1969.

2. In the Circumstances in exercise of the powers conferred by sub Rule (2) of Rule 8 of ATS (D&A) Rules, 1969, Government appoint Shri.R. Raja Raja Varma IFS (KL: 1978). Chief Conservator of Forests. Regional, south Kollam as the inquiring Authority to enquire into the charges against Shri.Jupudi Prasad, IFS.Government also appoint Shri. A.K. Goyal IFS(KL:1981), Conservator of Forests, Central Circle, Thrissur as the presenting officer to present the case in support of the Articles of charge in the inquiry ordered against Shir, Jupidi Prasad IFS, Under Rule 8(6) (c) of AIS (D&A) Rules 1969

3. The inquiring Authority will complete the inquiry and submit his report as expeditiously as possible.
