**Abstract**

Forests- sale of tree growth in 1973 R.A. coupe XX in Vazhachal Range of Chalakudy Division – auction dated 18-12-73-belated remitted of balance 1/3<sup>rd</sup> value –sanction accorded.

**ORDER**

In his letter read above the Chief Conservator of Forests has reported to Government that Shri.V.T. Poulouse, Vattichira House, Nellikuzhi, Kothamanglam bid to auction dated 18/12-72 the right of collection and removal of tree growth in 1973 RA and coupe No.VIII of coupe No.XX in Vazhachal Range of Chalakudy Division for Rs.60100/-. He has remitted the EMD of Rs.1000/- only and did not remit the required amount towards balance 1/3<sup>rd</sup> amount of Rs.9000/- on the date of auction. As per condition 2 of the sale notice he should remit 1/3 of the bid amount of Rs.10,000/- whichever is less, immediately after the close of the sale failing which his Earnest money deposit will be forfeited and the coupe resold at his risk and loss. But the highest bidder put in a petition on 19-12-72 before the Conservator of Forests requesting to allow him to remit the amount with penalty or penal interest. The Divl. Forest Officer, Chalakudy recommended to the Conservator of Forests, Trichur that the request of the highest bidder may be allowed as the price fetched in respect of he above sub coupes is very attractive ad that a better price will not be fetched if a reauction is tried. The matter was therefore discussed and the Chief Conservator of Forests issued orders to permit the bidder to remit the balance 1/3<sup>rd</sup> amount of Rs.9000/- with penal interest at 12% per annum.

2.Accordingly the bidder Shri.V.I.Poulouse has remitted the balance 1/3<sup>rd</sup> amount of Rs.9000/- plus penal interest of Rs.90/- as per Mukundapuram Sub Treasury chalan No.2024 dated 27-12-72 and the same has been credited in the Division accounts as per cash book item No.103 dt.29-12-72. So the sale has been confirmed by the Conservator of Forests, Trichur as per his proceedings No.CH.20663/72 dated 3-1-1973.

3.The Chief Conservator of Forests requests Government to ratify his action is having issued orders to allow the bidder to remit the balance 1/3 amount of Rs.9000/- after realizing the penal interest at 12% for the belated remittance and also to accord formal sanction in the matter.

Government accept the recommendation of the Chief Conservator of Forests and they order accordingly.
