## **ORDER**

Officers of Forest and Wild Life Department have been delegated with financial powers vide Government Order read as first paper. As per item number 21 of this Government Order, full powers have been given to the Conservators and Chief Conservators of Forest to confirm sale of cashewnuts and pepper. Besides delegation for an amount up to Rs.50,000/- have been given to Deputy Conservators, Assistant Conservators and Divisional Forest Officers for this purpose. However, powers have not been delegated to confirm sales of certain usufructs like coffee, cardamom, arecanut, grampoo, rubber latex and rubber standing tree to the above officers for which at present Government sanction is required.

Now the Chief Conservator of Forests (Protection) has requested to delegate Forest Officers with powers to confirm the sale of coffee, cardamom, arecanut, grampoo, rubber latex and rubber standing tree.

The Empowered Committee in its meeting held on 29/12/09 recommended the proposal of the Chief Conservator of Forest.

Government have examined the proposal and decided to enhance the financial powers of various officers of Forest and Wild Life Department for the confirmation of sale of coffee, cardamom, arecanut, grampoo, rubber latex and rubber standing tree as follows.

Forests, Up to Rs.50,000/- for each sale of Deputy Conservators of Assistant Conservators of Forests, usufructs like coffee, cardamom, Divisional Forest Officers. arecanut, grampoo, rubber latex and rubber standing tree.
