Rehabilitation of displaced persons from former East Pakistan – Age concession to bonafide migrants from the former East Pakistan for appointment in Government Service – extension of period – orders issued.

ORDER

In G.O. read as first paper above, order were issued granting age concession to the bonafide displaced persons from East Pakistan who have returned to India during the period from 1.1.1964 to 25.3.1971 up to 31.12.1975 as advised by the Government of India. In their letter read as second paper, the Government of India have intimated that the age and fee concession granted to displaced persons from East Pakistan have been extended up to 31.12.1977, in consultation with the Union Public Service Commission and have requested the State Governments also to take appropriate action.

2. Government have considered the question in consultation with the Kerala Public Service Commission and are pleased to order that the concessions regarding age allowed to bonafide displaced persons from East Pakistan, who have returned to India during the period from 1.1.1964 to 25.3.1971, for appointment to various posts in the services under the state will be extended up to 31st December 1977. The maximum age limit for entry into Government Service as well as for permanent absorptions belonging to Scheduled castes or scheduled Tribes both in cases of gazetted and non- gazetted posts. The age relations will be made applicable only from the date on which the provision is include in the Gazette Notification of the Kerala Public Service Commission.

3. In order to qualify for above concessions, the candidates concerned will have to produce satisfactory evidence of being bonafide displaced persons from East Pakistan who have migrated to India on or after 1st January 1964. Certificates issued by the Commandant of the Transit Centres of the Dandakaranya Project or the camp commandant of the Relief camp in various states or the District Collectors of the areas where the candidates may for the time being be resident will be accepted as sufficient proof of their bonafides as displaced persons from East Pakistan.
