TESTS-DEPARTMENTAL TESTS- PASSING OF- RE-INTRODUCTION OF THE SYSTEM OF ISSUE OF CERTIFICATES TO SUCCESSFUL CANDIDATES-CASES WHERE THE CANDIDATES QUALIFY BY PASSING THE CORRESPONDING PAPERS IN ANOTHER TESTS-PROCEDURE TO BE FOLLOWED INSTRUCTIONS ISSUED.

ORDER

1. In the G.O. read above orders were issued reintroducing the system of issue of certificates to candidates who pass in full one or more of the Departmental Tests conducted by the, Public Service Commission, and deputing to then exiting practice of publishing the full address of the successful candidates with their register numbers in the Kerala Gazette. Reference of Rs. 5 (Rupees Five only) was also ordered that to be realized for each certificate. According to this revised procedure, certificates will be issued only for those candidates who pass the test in full or complete the test in parts.

2. It has been pointed out that this procedure will cause difficulties in cases where a person can be deemed to have passed a test without passing that test in full but by passing the corresponding papers in another test. Governments have examined in consultation with the Public Service Commission the question as to how this difficulty could be obtained. As agreed to by the commission, Government are pleased to order that candidates who qualify in a test by passing corresponding papers in another test will also be issued certificates, on realization of the fee prescribed in the G.O read above.
