*Sub:-* Public Services- Kerala General Subordinate Services – Post of Driver- Filling up- further instructions issued.

*Ref:-* 1. G.O. (P) No.202/72/PD dated 22-5-1972.

2. G.O. (P) No.120/73/PD dated 30-4-1973.

As per special rules for the appointment of Drivers issued in G.O. (P) No.120/73/PD dated 30/4/1973, the method of appointment is,

(i) by promotion from any other class or category in the General Subordinate Service or by transfer from any other service, or

(ii) in the absence of suitable candidates under item (i) above, by direct recruitment.

According to the procedure prescribed in the G.O first cited for the recruitment of Driver by transfer, the vacancies of Drivers arising in various departments will have to be reported to Divisional Employment Exchange. The Employment Exchange will advise candidates for appointment by transfer as Drivers. The appointing authority need address the Kerala Public Service commission only if candidates are not available with in employment Exchange.

It has come to the notice of Government the certain Appointing Authorities are not strictly following the procedure laid down in the G.O.dated 25-5-1972. In the circumstances Government direct that all appointing Authorities shall strictly follow the procedure prescribed in G.O.(P) No. 202/72/PD dated 22-5-1972 regarding filling up of the post of Driver.
