Tenders were invited to be received on 30-5-1973 by the Divl. Forest Officer, Malayattur for the following works:

The tender notice was published in Gazatte date 22-5-1973 pages 244 and 245 of Forest Sheet and in Malayalam Dailies Malayala Manorama, Kottayam and Kozhikode dated, 22-5-1973, Mathrubhoomi, Kopzhikode dt. 22-5-1973 and Cochin dt. 23-5-1973. The tenders were received on 30-5-1973.

It is reported by the Divl. Forest Officer, Malayattur that wide local public publicity was also given for the work. 10 persons presented tenders for the work. The percentage of the standard rate offered by the tenderers is noted below:
