The Grazing fee now Charged in Sungam and Parambikulam Ranges are given below.

Parambikulam sanctuary is now being developed by merging Parambikulam Ranges also into the existing sanctuary that comprises of Sungam Range only. For the development of a sanctuary it is highly necessary to control cattle grazing effectively. As the grazing fee levied in this sanctuary is only nominal as indicated above, effective control is to increase the grazing fee.

The grazing fee sanctioned for Periyar sanctuary as per G.O. MS.141/67/Agri. dt. 1.4.1967 is as below.

In order to have a uniform procedure and an effective control grazing I am directing the concerned sub officers of this department to realism grazing fee in the two Ranges also at the enhanced rates sanctioned for Periyar sanctuary with effect from 1.4.1973 My action may be ratified.
