**ORDER**

The Chief Conservator of forests, in his letters read above has reported that there are no prescribed rates in the forest schedule of rates for digging pits and filling polythene Bags for pepper planting. He has also requested Government to approve the rates proposed by him for digging pits and filling polythene bags.
