ORDER

Government had appointed about 40 working groups to examine all the continuing schemes taken up under the Sixth Plan to see whether they had worked well to drop those which were not good or have out lived their useful, with or without modifications. Based on this, a number of schemes which were dropped in the plan and there are a few more scheme to be dropped. There were many schemes which are started during a plan, which have to be continued under non-plan. Similarly, there are schemes which are started during a plan period and which need not be continued after the plan period . It is necessary to consider as to which of the schemes started during plan should be continued and which need not be continued.

Government w are therefore pleased to order that a committee of Secretaries will be constituted with the Finance Secretary as Chairman and the Secretary, Finance (Expenditure) Department, the Secretary, Planning Department and the Secretary, Personal and Administrative Reforms Department at the other members. The secretary, Finance (Expenditure) Department will be the Convener of the Committee, who will process the proposals. The secretary concerned will be invited for the discussion.
