**ORDER**

The district Collector, Ernakulam in his letter read above has reported that an extent of 6.30 acres of land transferred to the revenue Department as per the Government order read above for allotment to Agriculture Department was handed over to the Agriculture Department by the Tahasildar, Muvattupuzha in anticipation of Government sanction and he has requested that the action of the Tahsildar in having given possession of the land to the agriculture department may be ratified. The District Collector has also requested to issued formal sanction transferring the land from the Revenue Department to the Agriculture department . The Secretary, Board of Revenue in his letter read above has recommended the proposal of the District Collector , Ernakulam on condition that the agriculture Department will pay the value of the tree growth to the Forest Department at the rates fixed by the Forest Department.

2. In the Circumstances stated sanction is accorded for the transfer of 6.3 acres of land in sy. No. 732/1 of Kuttamangalam Village , Ernakulam District from the revenue Department to the Agricultural department free of cost for the purpose of establishing an Agricultural Farm and on condition that the Agriculture Department will pay the value of the tree growth to the Forest Department at the rates fixed by the Forest Department, as recommended by the Bard of Revenue.

3. The Secretary, Board of Revenue will make necessary change to the revenue Records.
