Government have examined the matter in detail and are pleased to order that the prior Government Service of University employees will be reckoned for service weightage for fixation of pay as per Pay Revision Order 2009 but it will not be reckoned for any other service benefits.

As such last sentence of the 'Note' below Rule 4 of Annex II of Government Order read as 1st paper above shall be modified as follows: "However prior Government service and aided school service will be reckoned for service weightage".

This Order will take effect from 1-7-2009.
