# GOVERNMENT OF KERALA Industries "F" Department ORDERS

No.2809/F3/77-1/ ID

Dated, Trivandrum, 29th January 1977

S R O No. 105/77- In exercise of the powers conferred by sub-clauses (2) and (3) of rule the Defense and Internal Security of India Rules, 1971, the Government of Kerala hereby make the following amendments to the Kerala Raw Cashew nuts (Marketing and Distribution) Order, 1976, published as S R O No. 638/76 in the Kerala Gazette Extraordinary No.357 dated the 9th june, 1976, namely;-

# **AMENDMENTS**

In the said Order;-

- (a) in clause 3, the proviso to sub-clause (1) shall be omitted;
- (b) for clause 10, the following clauses shall be substituted, namely;-
- "10 .Distribution of raw cashewnuts to cashew factories;-
- (1) All raw cashewnuts purchased by the agents and sub- agents under this order shall be distributed to the Cashew factories in the State which are registered in pursuance of the rules made under the Factories Act.1948 (Central Act of 1948) in accordance with such principles as the Government may, by order published in the Gazette, decide from time to time.
- (2) An Order under sub clause (1) shall also be served on the agents and the occupiers of the Cashew factories referred to in that sub- clause.
- (3) The Cashew Special Officer shall, in accordance with the principles decided by the Government under sub-clause (1) by order specify the quantity to be distributed to each cashew factory.

- (4) An order of the Cashew Special Officer under sub- clause (3) shall be served on the agents and the occupiers of the Cashew factories eligible for the allotment of raw cashewnuts under that order.
- (5) The Cashew Special Officer or the agent shall give notice to the occupier of every cashew factory eligible for the allotment of raw cashewnuts requiring him to take delivery of the raw cashewnuts to his factory at the place specified in the notice within three days of the service of the notice.
- (6) If any dispute arises out of any order of the Cashew Special Officer under subclause (3) such dispute shall be referred to the Government whose decision thereon shall be final.
- 10 A. Duty of occupier to take delivery of raw Cashewnuts;-

If the occupier of a cashew factory fails to take delivery of the raw cashew to in sub-cashewnuts allotted to his factory at the place and before the date referred to in sub-clause (5) of 10, he shall forfeit the allotment and such raw cashewnuts shall be disposed of by the government in such manner as they may deem fit".

- (c) after clause II, the following clause shall be inserted, namely;-
- "IIA. Processing of allotted Raw Cashewnuts to be done in the concerned factory-Roasting, Shelling, peeling and grading of raw cashewnuts allotted to a cashew factory under this order, shall be done only in that factory and no other place"
- d) in clause12, in the opening paragraph, for the word" tahsildar" the words "Revenue Inspector" shall be substituted.

#### **Explanatory Note**

(This does not form part of the notification but is intended to indicate its general purport).

Government have decided to empower the Cashew Special Officer to order the distribution of the raw nuts to cashew factories and to make the allottee responsible for lifting the quota and to make certain other changes in the distribution policy. It is also considered necessary to enforce the order more effectively. The amendments are intended to achieve the above objectives.

S R O No106/77;- In exercise of the powers conferred by sub-clause (1) of clause 10 of the Kerala Raw Cashewnuts (Marketing and distribution) Order,1976 the Government of Kerala here by decide that the raw cashewnuts purchased by the agents and the sub- agents under the order shall be distributed to the cashew

factories referred to the said sub- clause in accordance with the following principles, namely;-

#### **PRINCIPLES**

Raw cashewnuts shall be distributed on the basis of the muster roll strength as on the Ist January, 1976, or the licensed strength of workers, whichever is lower;

Provided that in the case of a cashew factory which is not eligible for imported nuts under the Import Trade Control Policy for the time being in force of the Government of India, no allotment shall be made unless the factory has worked for not less than one hundred days during the calendar years 1975 and 1976.

### **Explanatory Note**

(This does not form part of the notification but is intended to indicate its general purport).

It is considered desirable to distribute the raw cashewnuts to factories on the basis of the muster roll strength or the licensed strength of workers whichever is lower. It is also necessary to distribute the raw cashewnuts procured locally to the licensed Cashew Factories in the State which had worked for not less than one hundred days during the calendar years 1975 and 1976 and which are not eligible for imported nuts under the Import Trade Control Policy. Hence the Notification.
