

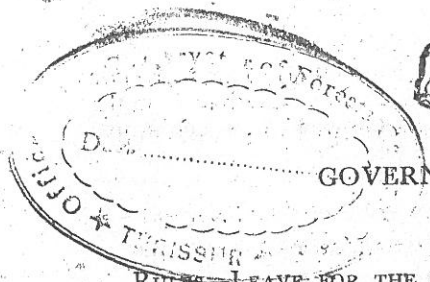

ORDER

The Government order read as first paper lays down guidelines for sanctioning leave without allowances to officers for the purpose of joining spouse abroad or within the country. It was ordered in the Government Order second read that officers who want leave for short periods for the same purpose can also be granted eligible leave, except leave without allowances, to the extent necessary, subject to eligibility.

2. But clarifications have been sought as to whether leave without allowances in terms of the Government order first read can be sanctioned in combination with the eligible leave sanctioned for such purpose as per the Government Order second read and whether such eligible leave can be commuted retrospectively into leave without allowances to join spouse abroad or within the country, and vice versa.

3. In partial modification of the orders second read Government order that officers who want leave to join their spouse abroad or within the country for short periods not exceeding three months may be granted ordinary leave under Rule 77 (i) Part I, Kerala Service Rules. subject to eligibility and other conditions governing each kind of leave. But when an officer who avails of such leave upto three months continuously seeks extension of leave, the leave already availed will be retrospectively commuted into leave without allowances to join spouse and the conditions mentioned in the Government order first read shall be made applicable abinitio. In case the earlier leave included earned leave, such commutation

will be granted in relaxation of the Proviso to Rule 89 (i), Part I, Kerala Service Rules. However, the leave without allowances sanctioned under the Government order first read shall not be allowed to be commuted retrospectively into leave of a different kind.
