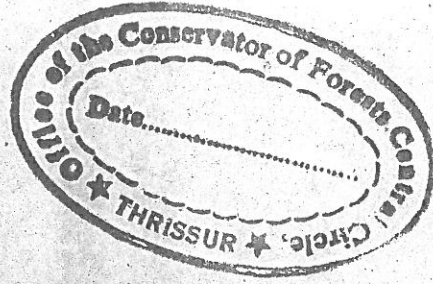

ORDER

In the G.O. read as second paper above orders have been issued to refund the two months' emoluments deducted from the Death-cum-Retirement Gratuity of those who retired during the period from 1-4-1964 to 30-9-1977 in cases where the pensioner is a widow/widower with no other eligible member to receive family pension.

2. Government have received many representations to refund the amount so deducted to all the pensioners, without any discrimination. Government have examined the matter in detail and are pleased to order that the two months' emoluments recovered from the Death-cum-Retirement Gratuity of those who retired during the period from 1-4-1964 to 30-9-1977 and those who are still receiving pension shall be refunded.
