ORDER

In the G. O. read as first paper, Government have ordered among other things, that the re-employment salary of Government servants who are re-employed in Government/Autonomous bodies after their retirement on attaining the age of superannuation, will be the last gross salary drawn minus pension. The officers so re-employed will not be eligible for any further instalments of D. A. or other increases sanctioned by Government to officers in service from time to time.

2. The A. G. has pointed out that the pension fixed under the orders in the G. O. read as second paper will be substantially, higher than the original pension sanctioned to the officers who retired prior to 1-7-1988, because of the fact that the D. A. on pension upto 608 points, adhoc

increase and difference due to application of 50% formula are also added to the original pension. Therefore the re-employment salary of such officers will have to be re-fixed w.e.f. 1-7-1988, as a result of the increase in pension.

3. Government have examined the case in details. They are pleased to order that in respect of Government Servants who retired from service prior to 1-7-1988 and re-employed in Government service or autonomous bodies of State Government; their re-employment salary as on 1-1-1990 or the date of re-employment whichever is later will be re-fixed taking into account the enhanced basic pension admissible as per the G. O. read as second paper. The excess pay drawn will be recovered from re-employment salary of the officers concerned.
