ORDER.

The Chief Conservator of Forests, Trivandrum vide his proceedings read as first paper above, awarded the following punishments to the delinquent subordinates as noted against each:

for the following charges levelled against them:

1. That they failed to detect the illicit felling of one Rosewood tree, trace out the thondy and apprehend the accused resulting a loss of Rs. 5000/- to Government.
2. That they actively connived in smuggling of Government timber.
3. That they tried to destroy the evidence to detect the irregularity.

2. The Chief Conservator of Forests vide his reference read as second paper above, has forwarded the appeal petitions from the delinquent officers serialised as 1,3,4,5 & 7 above for the consideration of Government.

3. Government have examined all the appeal petitions in detail with the relevant records received from the office of the Chief Conservator of Forests with particular reference to the statement on 19.5.1980 made by Sri.N.Sivanandan, Forest Guard before the then Range Officer, Flying Squad, Trichur. The statement reveals that the officers in this Range were aware of the smuggling of Government timber, even before it was brought to light by the press (press cutting of Janayugam daily dated, 30.9.78). They are silent about this in the appeal petitions filed before Government not did they point out that the statement made by Sri.Sivanandan was wrong. The Range Officer has failed on his part to act in spite of his wilful knowledge of the smuggling and ~~the~~ of the smugglers. Besides the piece of Rosewood tree traced out as evidence was also smuggled by the Range Officer, the Guard Sri.Philip, and the Forester Sri.Jayan. It is understood that the smuggling of the timber was made about 10 months before the news appeared in the press. Sri.T.P. Antony, Forest Guard took charge in this beat on 27.9.1978 and Sri.V.Achuthan, Forest Guard had a service only for 1 month and seven days before 24.5.1978. They are to be absolved from the charges against them. Similarly, Sri.Sivanandan, Forest Guard who is less experienced in service and also gave information to the Range Officer and also gave information to the Range Officer and co-workers about the smuggling then and there also deserves no punishment and they Government orders accordingly. The following officers are found to have failed in their roles in booking the smugglers and trying to recover the smuggled wood and in trying to destroy the evidence ie. the piece of wood, without reporting:

1. Sri.C.Chandran, Range Officer (now Assistant Publicity Officer, Calicut.
2. Sri.K.C.Jayan, Forester.
3. Sri.T.P.Philip, Forest Guard.
4. Sri.M.K.Porinchu, Forest Guard.

4. The Hon'ble High Court in their judgment read as third paper above have directed to consider and pass orders on the appeal petition dated.14.2.1983 of Sri.M.K.Porinchu in this case.

5. And Now, in consultation with the Kerala Public Service Commission, Government award the following punishment noted against each to the delinquent officers disposing of their appeal petitions:

1. Sri.C.Chandran, Range Officer.
(Now Assistant Publicity Officer, Calicut.)

Recovery of Rs.1000/- from the total loss of Rs.5000/- in 10 instalments AND barring of one increment with cumulative effect.
