ORDER.

Chief Conservator of Forests in his letter read as first paper above has proposed to divert 2.5 Cents (0.01 ha) of forest land at Varandarapilly Panchayath, Kodakara Block, Thrissur District for construction of pump House and laying delivery and auction pipe. Government of India in their letter read as second paper above have accorded sanction under, Forest Conservation Act for the above proposal.

In the above circumstances sanction is accorded to divert 2.5 cents (0.01 ha) of forest land for the construction of a Pump House and laying delivery and Suction pipe at Varandarapilly Panchayath, Kodakara Taluk, Thrissur District subject to the following conditions.

- The legal status of the forest land involved will remain unchanged.
- The period of lease of the said area will be for 10 years.
- Renewal of proposal for lease of the forest land shall be submitted six months before expiry of the lease period.
- No tree felling will be permitted. The minimum number of trees to be planted shall be computed at a rate of 2500 trees per hectare for the area actually diverted at the cost of user agency as per the latest guidelines of the Government of India vide letter No. 2-1/90_FC, dated 3rd February, 1990.

The Chief Conservator of Forests will take further necessary action in the matter.
