ORDER

1. Smt. Rajalekshmy was appointed as Lower Division Clerk in the Office of the Conservator of Forests, Trichur on the advise of the Public Service Commission and who joined duty on the afternoon of 1—1—1966. As who was then studying in the first year class of the III year B.Sc., she applied for leave for study purposes for a period of two years and 5 months with effect from 10-11-1966 in order to complete her studies. The Conservator of Forests refused the leave and terminated the services of the clerk. The Conservator of Forests refused the leave on the ground that it was not possible to get a substitute in view of the restrictions on filling up of leave vacancies.

2. Smt. Rajalekshmy has requested that the orders of the Conservator of Forests may be cancelled and leave granted to her in view of Rule 91 Part I Kerala Service Rules.

3. Government have examined the case very carefully. Though the sanctioned authority can sanction or refuse leave at his discretion Government feel that the Conservator of Forests did not exercise his discretion properly in the instant case, especially in the light-of Rule 91 Part I Kerala Service Rules. Further the orders terminating the services were issued not after following the prescribed-procedure as there is no provision to terminate one's service. The provision is for removal from service

after following the procedure in Kerala Civil Service (classification, Control & Appeal) Rules.

4. In the circumstances Government direct that the orders of the Conservator of Forests be cancelled and Smt. Rajalekshmi granted ;leave for study purposes under Rule 91 Part I Kerala Service Rules.
