### ORDER

With a view to revitalize Wildlife Conservation and to ensure specialized management in the field, the Government of India have repeatedly stressed the need for the formation of a separate Wildlife Wing in the State. Considering the various suggestions contained in the Government of India's letter in this regard, the Chief Conservator of Forests (Wildlife), in his letter read as 3<sup>rd</sup> paper above, furnished to Government detailed proposals for the formation of a separate Wildlife Wing in the State so as to achieve the main objective of preservation and better management of the Wildlife Sanctuaries and National Park in the State. The proposal of the Chief Conservator of Forests (WL) was also based on the Government of India guidelines for the creation of additional staff in various levels for the consolidation and better management of the newly created Wildlife Wing.

2. After considering the matter in all its aspects, Government are pleased to accord sanction for the creation of a separate Wildlife Wing with effect from 1.3.1985. Government are also pleased to accord sanction for the creation of the following additional posts for the better management of the newly created Wildlife Wing.
