**ORDER**

In the G.O. read as first paper above, it was ordered that Rule 11 of the State Provident Fund (Travancore) Rules and Rule 12(1) of the General Provident Fund (Cochin)Rules would be amended on the lines of the Rule 14 (1) © of the General Provident Fund (Madras) Rules. Certain clarifications in the matter were issued subsequently in the G.O.s and the Circulars read as 2<sup>nd</sup>, 3rd, 4th, 5th Paper above.

2. Under Rule 12 (2) of the General Provident Fund (Central Services) Rules, 1960 an advance shall not, except for special reasons to be recorded in writing be granted to any subscriber in excess of three month's pay or half the amount standing to his credit in the Fund, Which ever is less, or until repayment of the last installment of any previous advance. For the purpose of this rule, pay includes dearness pay, where admissible.

3. Government have considered the desirability of modifying Rule11 of the State Provident Fund (Travancore) Rules, Rule 12(1) and 12 (3) (i),(iii) and (iv) of the General Provident Fund (Cochin) Rules and Rule 14(1) © of the General Provident Fund (Madras) Rules on the line of Rule 12 (2) of the General Provident Fund (Central Services) Rules, 1960 as the letter takes away the restriction that in normal cases twelve months should have elapsed after repayment of all previous advances which exceeded 2/3 rds of the amount normally admissible at the time of their sanction) with interest there on for the grant of a fresh advance, and they order that the rule relating to State Provident Fund (Travancore), General Provident Fund (Cochin) and General Provident Fund (Madras) referred to above will be modified on the lines of Rule 12 (2) of the General Provident Fund (Central Services) Rules, 1960. The dearness pay will also taken in to account for sanctioning temporary advances

from Provident Fund deposits of a Subscriber hereafter. These orders will take immediate effect.

4. Suitable amendments to the relevant rules will be issued in due course.
