ORDER

According to Government Decision No.2 below Rule 7, Appendix VIII, Kerala Service Rules, the leave earned by provisional recruits during provisional service diminished by leave, if any, already taken will be carried forward on regularization of their provisional appointment without any interruption. This does not bring out the distinction between professional employees whose service get regularized ab initio and those whose service gets regularized from a letter date. Professional recruits become eligible from for the ordinary leave admissible to regular employees any from the date of regularization of their professional service.

2.In order to make the intention clear, Government hereby orders that in Appendices VIII of the Kerala Service Rules, under Government decision No. 2 below Rule 7, the following sentence shall be added as a separate paragraph.

" The provisional recruits will be eligible for the leave admissible to regular employees only from the date of regularization of appointment".
