ORDER

According to the orders in the G.O. first read above, five percent of the vacancies arising in the ordered of L.D. clerk, L.D. Typise, Typist –clerk and copyist are reserved for persons holding low paid posts who secure not less than 40% marks in the competitive test conducted by the Public Service Commission for selection to the above posts. In the G.O. Second read above, the above concession was extended to the selection to the post of Typist Grade II in the Secretariat, in the office of the Public Service Commission, the Advocate General and the Examiner of Legal Fund Accounts Subject to the condition that the low paid employees , who passes the minimum typewriting examination prescribed for the post alone will be allowed to appear for the competitive test conducted by the Public Service Commission for selection to such posts. In the G.O.third rend above, two percent of vacancies arising in the order of Assistant , Grade II, Grade II Auditor are also reserved for persons holding low paid posts with four years agree gate service in their respective category of posts and having the minimum educational qualification prescribed for appointment to the post of Asst. Grade II/Grade II Auditor for direct recruitment . Those who secure not less than 40% marks in the competitive test conducted by the Public Service Commission will be selected for appointment to the post.

2. But there is no reservation for the persons holding low paid posts in the matter of appointment for the post of confidential Asst. vacancies of confidential Assistants are filled up by direct recruitment and promotion from qualified Typists in the ratio of 1:1

3. Government have examined the proposal for giving cession to the low paid employees in the matter of appointment the post of confidential Assistant Grade II in consultation with the P.S.C and they are pleased to order that two peresent of vacancies of confidential Assistants, Grade II set apart for direct recruitment will be reserved for appointment of low employees included in the last Grade Service and subordinate service who passes the minimum qualifications prescribed for appointment of confidential Assistant, Grade II and who secures not less than forty peresent marks in the competitive test conducted by the P.S.C.

4. Following the procedure prescribed in the G.O.fifth read above, the names of the low paid employees who secure 40% minimum and above in the selective test conducted by the P.S.C and thus became qualified for appointment as confidential Assistant Grade but could not secure appointment before the expiry of ranked list will he included at the top of the new selected ranked list of the low paid employees irrespective pf service and seniority and they will be given appointment accordingly.
