To autonomoOus bodies public undertakings to the public interest Government are not bound to pay any retirements benefits for the period of service rendered by the officer before his transfer in cases of permanent transfers s on their own volition

2. The Accountant General , Kerala in his letter read as third paper above has pointed out that Government of India has removed the distinction between absorption in "Public Interest and "Own volition,"

3 Government have examined the question in detail and are please to order that even in cases where such Transfer to autonomous body / public undertakings are in own volition . Government shall pay retirement benefits for the period of service rendered by the Government employee before his transfer .

4 The G.O read as second paper above will second modified to the extent indicated above .

5 This order will take effect from 29-8-1984 . The cases already settled otherwise need not be re-opened .
