ORDER

As per the G.O. read as second paper above, the payment due under Family Benefit Scheme in the case of a minor is to be deposited in the Treasury Savings Bank to nature on the minor attaining majority. But the term deposits as per rules of the Treasury Savings Bank are to be in multiples of Rs. 100. At times, the share due to the minor happens to be not in multiples of Rs. 100. As such, the Drawing and Disbursing Officer concerned will not be in a position to deposit the share amount due to the minor in the Treasury Savings Bank as term deposit. In view of the above, the Government are pleased to issue the following further orders in the matter:

In the circumstances where the Drawing and Disbursing Officers will not be in a position to deposit the share due to the minor in multiples of Rs. 100, they are hereby permitted to accept from the guardian of the minor for anybody else on behalf of the minor the minimum voluntary and unconditional contribution to add up to the actual share amount in order to make the amount a multiple of Rs. 100 and then deposit the amount in multiples of Rs. 100 (ie., the actual amount due to the minor and voluntary contribution received) as term deposit in the Treasury Savings Bank Account to mature on the minor attaining majority. In case where the Drawing and Disbursing Officer is satisfied that there is no possibility of getting the required voluntary contribution, the share amount of the minor may be deposited in Treasury Savings Bank in multiples of Rs. 100 (by lower rounding the amount to the nearest multiples of Rs. 100) and the balance amount which will be below Rs. 100 may be disbursed to the guardian or any other major member (s) in the family of the deceased subscriber on a simple receipt. The despoit certificates due to the minors may also be handed over to the guardian of the minors after receiving proper acknowledgement.

No alteration need be made in those cases where the payment due under Family Benefit Scheme have already been made.

The G.O. read as second paper above stands modified to the above extent.
