**ORDER**

In the G.O.read above, certain revised procedures were in the interest of quick settlement of communication claims and avoidance of hardships to pensioners. The Accountant General, in the reference read as second paper above, suggested certain modifications to the above .G.O.

Government have examined the suggestions in detail and are pleased to order the following modification to the above G.O.

- (i) The first sentence in Para 3 (i) of the G.O. is modified as follows:-

“ In case where application for communication of pension is submitted on or before the date of retirement, communication shall become absolute on the date following the date of retirement”.

- (ii) The words ‘On or ‘ occurring in Para 3 (ii) of the G.O. are deleted.

(iii) In Para 3 (ii) itself, the latter part namely, the date of receipt of the application by the pension sanctioning authority is modified as the date of receipt of the application by the Accountant General/pension sanctioning authority.

The G.O. read above will stand modified to the above extent.
