ORDER

In the G.O read as first paper above it was ordered among other thing that while calculating the average emoluments of these employees who retired after 1-7-1983 dearness allowance and Ad-hoc dearness allowance at 488 points would also be reckoned along with their for that part of the 10 months period during which the employees drew in the per-revision scales.

2. The Accountant in his letter read above has pointed out that since Dearness Allowance and Ad-hoc Dearness Allowance at 448 points were sanctioned only from 1-5-1983. Certain department officers have raised doubts regarding the reckoning of D.A at 488 points for the period prior 1-5-1983 which falls the last 10months of retirement and has therefore requested to issue necessary clarificatory orders in this regard.

3. Government are pleased to clarify that through D.A and Ad-hoc D.A at 488 points were sanctioned only from 1-5-1983, in case where the ten months period for calculation of average emoluments extends to period prior to 1-5-1983, fr such periods prior on 1-5-1983, D.A and Ad-hoc D.A at 488 points for the pay in the pre- revision scales of pay will be reckoned as emoluments.
