**ORDER**

In the G.O. read as first paper above, it was ordered that in the unfortunate event of the death of a Government employee, his liabilities due to Government up to Rs.2 lakhs will be written off. In the orders cited, it was ordered that the amount of Rs.2 lakhs ordered to be written off shall include House Building Advance, Motor Conveyance Advance and interest thereon and interest free Advance drawn for the treatment of the employees.

Government have received petitions from the surviving embers of the family of deceased Last Grade Officers to write off the outstanding balance of loans granted to Last Grade Officers under the scheme of assistance for the marriage of their daughters. Government have examined the matter in detail and are pleased to order that the amount outstanding against the loans granted to Last Grade Officers for the marriage of their daughters, at the time of the death of the Government Servant will also be included under the categories of liabilities outstanding against the deceased Government Servant. The Government Order referred 4<sup>th</sup> above stands modified to that extent.
