**ORDER**

In the Government circular read as third paper above , Government have clarified that Members of Scheduled Castes and Scheduled Tribes allotted from Madras and T.C. States to Kerala would be eligible for temporary emption from passing the unified Account Test and Tests in office Procedure introduced in the G.O. read as first paper above for a period of seven years from 14-1-63. In the G,O fourth cited a further extension of one year from 14-1-70 was granted to these case, Government have since received representations from the Kerala Harijan Samskarika Kshema Samithy, Trivandrum and the Government Employees Association (S.CS& S.TS. ) Kerala, Trivandrum requesting permanent exemption from the tests introduced in G.O. read as first [paper above to the allotted personnel belonging to the Scheduled Castes and Scheduled Tribes.

2. Government have examined the matter in consultation with the Public Service Commission and are pleased to sanction a further extension of the period of temporary exemption to allottees belonging to Scheduled Castes / Scheduled Tribes from passing the above tests by one year from 14-1-1971 as a special case in order to avoid hardship to such persons in service.
