GENERAL PROCEDURE-FURTHER ORDERS ISSUED.

ORDER

In the G.O. first cited Government have laid down a uniform procedure for dealing with the requests for appointments from relatives/ dependents of Government servants dying in harness. In the G.O. second cited it was ordered that the benefit of the G.O. dated 21-1-1970 would be confined to relatives/ dependents of Government employees whose family income does not exceed Rs. 2,400 per annum exclusive of any family pension being received by the dependents. In the G.O. third cited it was clarified that the income of a member of the family whose financial assistance is not available to the family need not be taken in to account while fixing the income of the family and that married sons and married daughters who are living with separate families need not be treated as members of the family for the purpose of fixing the family income and for applying the income limit as envisaged in the scheme as their financial assistance is not available to the family.

In certain cases the District Collectors have reported that unmarried relatives/dependents of the deceased Government servants who are employed are giving only a small portion of their salary to the family of the deceased Government servants and in certain cases they are not giving any financial assistance at all. In such cases it has become difficult to assess the family income of the deceased Government servant for the purpose of extending the concessions contemplated in G. O.(Ms) No. 20/70/PD dated 21-1-1970.

Government consider that every unmarried member of the family of a deceased Government servant has got the obligation and moral responsibility to support his family. The total income of the family has necessarily to be computed taking in to account the total income of each and every unmarried member of the family as also the common incomes, if any of a family from properties etc. Government therefore order in partial modification of the order issued in the G.O. third cited that the entire income of all unmarried members of family of the deceased Government Servant irrespective of whether they give any assistance to the family or not shall also be counted for computing the income of the family for the purpose of granting the concession contemplated in the G.O. (Ms) No. 20/70/PD dated 21-1-1970.
