PUBLIC SERVICES-PROVISIONAL (TEMPORARY) PHYSICALLY HANDICAPED EMPLOYEES WHO WERE IN SERVICE ON ANY DAY FROM 22-12-1973 TO 1-1-1974, WHO WERE RELIEVED AFTER 22-12-1973-TEMPORARY SERVICE RENDERED THROUGH EMPLOYMENT EXCHANGES BETWEEN THE DATES OF THEIR RELIEF AND RE-APPOINTMENT-COUNTING OF-ORDERS ISSUED

**ORDER**

In the G.O. read as 1<sup>st</sup> paper above it has been ordered among other things as follows:-

1. The Services of the physically handicapped provisional(temporary) employees who were appointed by direct recruitment under rule 9 (a) (i) of the Kerala State and Subordinate Services Rules, Part II, and who were in service on any day from 22-12-1973 to 1-1-1974 and who are now in service, will be regularised with effect from 29-4-1974, irrespective of the length of their service;

(ii) Candidates, if any , advised by the Public Service Commission on 29-4-1974 will be declared as senior to the physically handicapped provisional (temporary) employees whose services are regularised by this order;

(iii) In the case of the physically handicapped provisional (temporary) employees in service on any day from 22-12-1973 to 1-1-1974, who had been relieved after 22-12-1973, but who were subsequently reappointed, eligible leave plus leave without allowances beyond three months, in relaxation of rule 88 (ii) Part I, Kerala Service Rules, if necessary, will be granted to cover the period between the dates of their relief and re-appointment.

The Director of Employment has reported that some of the physically handicapped employees who were relieved from his department after 22-12-1973 have obtained temporary service through Employment Exchanges during the period between the dates of their relief from and re-employment in the department . He has requested for orders as to how the above period of the temporary service of these officers has to be treated to cover their break of service between their date of relief and reappointment in his department.

Government have examined the matter and are pleased to order the since orders for re-appointing the physically handicapped temporary employees who had been relieved after

22-12-1973 were issued only on 29-4-1974, the temporary service rendered by such physically handicapped employees after 29-4-1974, even if it is in a different category in a different unit/department, be treated as on other duty in those posts in which they are eligible for regularisation by virtue of their prior service during 22-12-1973 to 1-1-1974.
