S.R.O. No.164/80- In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act 1968 (9 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following amendment to the Kerala Service Rules, namely:-

AMENDMENT

C.S.No. 369/80

1. (i) These rules may be called the Kerala Service (Amendment) Rules, 1980.
(ii) They shall be deemed to have come into force with effect on and from the 1st day of November, 1959.
2. In Part 1 of the Kerala Service rules in Note 5 under rule 56 B,-
 - (a) after the word ‘ dismissed ‘ the words ‘ or removed ‘ shall be inserted.
 - (b) after the word ‘ dismissing ‘ the word ‘ or removing ‘ shall be inserted.

Explanatory Note

(This does not form part of the notification but is intended to indicate its general purport).

As per note 5 under rule 56 B if an officer under suspension is dismissed with retrospective effect from the date of suspension, no recovery should be made of the subsistence allowance already paid to him and arrears of subsistence allowance, if any,

due to him up to the date of the order dismissing him should be paid to him. A doubt has arisen whether note 5 under rule 56 B applies in cases of removal. After detailed examination it is clarified that the note 5 will apply in the case of removal also. The above notification is intended to clarify the applicability of note 5 under rule 56 B.
