**O R D E R**

In partial modification of Para 10 of the G.O. 3<sup>rd</sup> read above and also in super session of the G.O. read as fourth paper, Government are pleased to order that in respect of Government Servants dying in harness on or after 1-7-1983 (date of effect of the pay revision) there will be no income limit of the family of the applicant for eligibility for appointment under the dying in harness scheme.

2. In respect of Government Servants who died in harness prior to 1-7-1983 (ie. Till 30-6-1983) the annual family income limit stipulated in the G.O. read as third paper above shall continue in force.

3. In the case of deaths on or after 1-7-83 in which applications were not earlier made solely because of the ceiling on annual income then in force, the eligible dependents are given time till 30-4-1987 to apply for employment assistance under the scheme.

4. Applications for employment assistance under the scheme already preferred by the dependents on or after 1-7-83 under the then existing rules and which were rejected solely on the ground of income limit in force are also given time up to 30-4-87 to make fresh applications for employment assistance under the scheme. It is clarified that applications rejected on any other ground will not be reconsidered.

5. All the other conditions stipulated in the G.O. read as third paper above remain unchanged.
