NOTIFICATION

S.R.O.No. 176/87-In exercise of the powers conferred by subsection (i) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following rules further to amend the Kerala Service Rules, namely:-

RULES

C.S.NO. 449/87

1. Short title and commencement.- (1) These rules may be called the Kerala Service (Amendment) Rules, 1987.
(2) They shall come in to force at once.
2. Amendment of Rules.- In part 1 of the Kerala Service rules in rule 3, the following Note shall be inserted, namely:-

Note.- These rules as a whole shall not apply to the persons appointed to the service of the Government temporarily under rule 9 of Part II of the Kerala State and Subordinate Service Rules, 1958, except to the extent specified by the Government.

Explanatory Note

The Rules in Kerala Service Rules will normally apply to the persons who are in the whole time employment of the Government and who have been appointed to the service of the Government on a regular basis. The extent to which these rules apply to the provisional employees, i.e., the persons who hold temporary appointments under Rules of 9 of Part II of the Kerala State and subordinate Service Rules, 1958, will be specified

under the rules concerned as Government Decision, ruling, etc. The amendment is issued in order to make the above position clear.
