ORDER

As per the orders ~~xxx~~ read as 1st paper above Government have accorded sanction for the introduction of retail sale of teak on a pilot basis in five depots of Forest Department subject to certain conditions. Chief Conservator of Forests in his letter read as 3rd paper above reported that the functioning of the retail sale depots opened accordingly made encouraging results. On the basis of the decision taken in the meeting held by the Minister (Forest & Spots) on 11-11-03, Chief Conservator of Forests in the letter read as 3rd paper above submitted proposal to open retail outlets under 6 Timber Sales divisions as follows:

- (a) Thiruvananthapuram Timber Sales Division - Kulathupuzha.
- (b) Punalur Timber Sales Division - Konni, Veeyapuram.
- (c) Kottayam Timber Sales Division - Kothamangalam, Thalacode.
- (d) Perumbavoor Timber Sales Division - Mudical, Veetoor.
- (e) Palakkade Timber Sales Division - Aruvacode.
- (f) Kozhikode Timber Sales Division - Kannavam, Kuppadi, Kasargode/Manchakkal.

Government have examined the proposal and are pleased to accord sanction to open retail depots for the sale of timber in the above centres subject to the conditions in the Government Orders read above and also subject to the condition that no additional staff either now or later will be sanctioned for this purpose.

This issues with the concurrence of the Finance Department.
