ORDER

Government of India have informed that the crucial date for determining the upper age limit of trained apprentices for absorption in an industrial establishment may be determined by deducting from his age, the period of apprenticeship / training undergone by him as prescribed under the apprentices Act, 1961, subject to the condition that the apprenticeship / training is in the same organization or in the same line of work / trade, and suggested that the state Government may issue similar orders.

2. The age concession will be available only to those persons who have undergone apprenticeship/ training as prescribed under the Apprentices Act 1961, subject to the condition that the Apprenticeship / training is in the same organization or in the same line of work/ trade. Therefore, the age concession will have to be made applicable to all the appointments in non- gazette / class III and class IV/post in Government and to equivalent post in Government owned/ controlled companies, Boards, corporation, etc.

3. Government in consultation with the Kerala Public Service commission hereby order that the crucial date for determining the upper age limit of rained a prentices for absorption in government or in an industrial establishment against various posts/ services as detailed in paragraph 2 above, will be determined by deducting from his age the period of apprenticeship/ training undergone by him as prescribed under the Apprentices Act, 1961, subject to the condition that the apprenticeship/ training is in the same organization or in the same line of work/trade.
