ORDER

At present there are no specific directions as to whether an officer under suspension is eligible for official residential telephone/mobile phones during the period under suspension and also whether reimbursement of telephone charges will be allowed to him/her. Requests for clarification on this matter is being received from Various Departments.

Government after having examined the matter in detail are pleased to clarify that an officer who is provided with official residential telephone/mobile phone on Government account cannot hold and use the same during the period of suspension. No reimbursement will be allowed to an officer towards his/her official residential telephone/mobile phone charge incurred during the period of suspension. The order of suspension should specifically incorporate his/her ineligibility to use telephones in his/her official capacity.
