**ORDER**

In the Government Order read above, orders have been issued on how to fix pay under Rule 28 A or 37 (a) Part I KSRs, as the case may be, in cases where the basic pay, personal pay and stagnation increment in the lower scale taken together exceeds the maximum of the higher scale or not and also in cases where the sum total of pay + personal pay + stagnation increment + notional increment exceeds the maximum of the higher scale of pay.

In the letter read as second paper above, the Accountant General has raised a few points for clarification.

Government have examined the matter in detail and are pleased to issue the following orders:

- (i) Circular No. 38/92/Fin. dated 14-7-1992 will be cancelled w.e.f. 26-3-2006.
- (ii) In illustration No. 1, 'pay as on 1-7-2007' will be corrected and read as 'pay as on 1-4-2007'.
- (iii) If the pay exceeds the maximum of the master scale while fixing pay in accordance with provisions of the G. O. dated 15-6-2010, the pay be limited to the maximum.

- (iv) The restriction imposed under G. O. (P) 145/06/Fin. dated 25-3-2006 that the maximum pay, after adding 3 stagnation increments, shall not go above ₹. 33,100 shall be followed while fixing pay under these orders.
- (v) These orders will take effect from 26-3-2006.
