ORDER

The Director of Census Operations, Thiruvananthapuram as per reference cited has requested to release balance of amount for payment of Honorarium and training Allowance to Enumerators, Supervisors and Master Trainers and other district census functionaries including those in Forest and Special charges in Kerala. The Director of Census Operations has suggested to sanction the amount as advance and has to be reimbursed from Government of India.

Considering the exigency of amount to be released for the distribution of Honorarium, the District Collectors and Chief Forest Conservator(Development), Government are pleased to allot a total amount of Rs.13,67,17,850/ (Rupees Thirteen Crores Sixty Seven Lakhs, Seventeen Thousand, Eight Hundred and Fifty only) to the District Collectors and an amount of Rs.9,21,100/- (Rupees Nine Lakhs, Twenty One Thousand and Hundred only) to the Chief Forest Conservator(Development) as advance as per details below:-

The above amounts shall be debited from the head of account "8449-00-120-85 Deposit for payment of honorarium to Enumerators and salary to the staff in connection with 2011 census".

The District Collectors and the Chief Conservator of Forests are directed to ensure that the amounts allotted for various purposes connected with NPR and Census, are utilized for that purpose only and should not be utilized for any other purpose. Excess amount if any should be refunded to Government sufficiently early. They are also directed to release the amount to the concerned enumerator/ Supervisor etc immediately without delay.

The District Collectors and the Chief Conservator of Forests are also directed to furnish the utilization certificate reconciled with treasury and Accountant General and to furnish the same to Government as early as possible.
