ORDER

In the Government orders read above, Government have ordered certain Economy measures to conserve the recourses required for the plan and to effect economy in expenditure in the context of the financial difficulties experienced by the State. As the financial position of the State Government continues to be difficult and as the expenditure during the rest .of the year, particularly in February 1983,has to be restricted to the absolute minimum, Government are constrained to order certain further stringent measures in this regard. Accordingly the state Government orders that all payments from the treasuries during February 1983 will be postponed except in respect of the following inevitable items of expenditure:

1. Salary including the salary of the staff of aided schools and colleges and T.A. and D.A. subject to economy orders in force.
2. Wages
3. All charged items of expenditure
4. Telephone charges
5. Service pension including commutation and gratuity etc.
6. Feeding charges of Animals of the Animal Husbandry Department and Museums Zoos
7. Expenses connected with conduct of lotteries
8. Diet and Medicine charges of hospitals.
9. Dietary charges of Jails and Jail institutions.
10. Scholarship, Stipend, lump sum grant, mess allowance, etc .payable to students of Scheduled Castes and Scheduled Tribes and all other categories of students.
11. Petrol charges subject to limiting the same to 50% of the average consumption in December 1982 and January 1983.
12. Expences relating to various feeding programs for children
13. All other plan Schemes implemented for the benefit of Scheduled Castes and Scheduled Tribes and women
14. Fuel charges relating to Water Transport Department.
15. Agricultural Workers Pension
16. Unemployment allowance.
17. Destitute Pensions.
18. Assistance to widows for the marriage expenses of their daughters.
19. Expences relating to 100% Centrally Sponsored Schemes
20. Other Centrally Sponsored Schemes like N.R.E.P.,I.R.D.P.
21. Disbursements under public account

22. Nemom Bye Election Expenses

The Treasury Officers will ensure that no payment is made in February 1983 in respect of the items of expenditure ordered to be postponed. The cheque drawing officers will also see that the cheques are henceforth encashed from the treasuries, only against admissible items of expenditure mentioned above. Disciplinary action will be initiated against those officers who violated the instructions in this regard
