**ORDER**

1. In the G.O. read as first paper , the Government in the interests of forest Conservation ordered that all encroachers and other occupants in Churli- Keerithode should be evicted immediately. Accordingly 636 families were evicted from Churuli Keerithode in 1964 and the evicted families were resettled as shown below:-

i) Mookkanpetty	169 families
ii) MannanKala	92 families.

2. In the G.O. read as fourth paper it was ordered that 3840 acres of forest lands in Churli Keerithode will be Clearfield and transferred to the revenue department for distribution among landless agricultural laborers.

3. The Malanadu Karshaka Union , Kerala Karshska Sangam etc. have requested that the occupants evicted from Churuli Keerthithode itself.

4. The Minister for Forests and Harijan Welfare discusses the matter with the parties concerned at a meeting on 12-11-1968 and it was decided that the persons who

were evicted from Churuli Keerithode itself and 1-5-1969 was fixed as the date for rehabilitation.

5. The Secretary Board of Revenue and the District Collectors Ernakulam are requested to take necessary action in the matter and see that all the evictees are resettled in Churuli Keerthithode before 1-5-1969 positively.

6. The Chief Conservator of Forests will taken immediate steps for handing over the area to the Revenue Department sufficiently early.
