**ORDER**

Sanction is accorded to the transfer of an extent of 40. 46 Acres of land in Sy. No. 825 of Thekkumkara Village , Thalappally Taluk, Trichur District to the Irrigation Department for the purpose of the Pathazhakundu Dam after evicting the occupants thereon on payment of compensation for improvements and allotment of alternative land to eligible families as shown in the statement appended to this order. Alternative land needed for allotment to eligible evictees will be found from the land mentioned in paragraph 5 below. Land value as per Kerala Land Assignment Rules will be realized from the families to be provided with alternative land.

2. The expenditure on account of compensation will be borne by the Irrigation Department,

3. The question whether land value has to be relised from the irrigation Department will be examined separately in consultation with the District Collector, Trichur and Chief Engineer, Irrigation.

4. G.O. Rt , 2075/66/ Agri dated 25-8-66 read as 1<sup>st</sup> paper above is cancelled.

5. Sanction is also accorded to the disreservation and transfer to the Land Reforms Department of an extent of about 15 acres of Forest land in Vettikad Teak Plantation comprised in Sy Nos. 1507 and 1510 of Wadakkancherry Village, Thalappilly Taluk for disposal under Kerala Land Assignment Rules. Value of the trees on the land will be realized from the assignees.

6. The District Collector, Trichur will take further steps for implementing there above orders.
