ORDER

A large extent of land is required for rehabilitating the per to be evicted from the Ayyappancoil and Upputhara areas coming within the Idukki Hydro Electric Project area and Government are confronted with the problem of finding out suitable land for the purpose. In the G.O. read as first paper above Government have ordered the disreservation and transfer of 57.18 hectares of the land in Mundakayam coupe No.VII A to the Revenue Department in assignment to landless poor persons. This land was notified for assignment under the Arable Forest Land. Assignment Rules, 70 as Government notification read as IInd paper above. Applications for assignment of the land have been received and further action from assignment is pending. It has been reported that the land in is suitable for rehabilitating the occupants to be evicted from Ayyappancoil and Upputhara area and that the land has been sell by the Popular Committee constituted in pursuance of the decision of the conference held in the collectorate, Kottayam on 13-9-. The District Collector, Idukki has also reported in the letter as 4th Paper above that 86 families of Ayyappancoil had prefer land in Mundakayam coupe No. VII.A.

Government are pleased to order that the 57.18 hectares of land in Mundakayam coupe No.VII A in Kanjirapally Taluk be deleted from the scheme of assignment under the Arable Forest Land assignment Rules and that the above land will be utilized for resettling the evictees from Idukki Project Area.
