Sub:—Counting of service under Government of India|State Government|Autonomous Bodies for Pension—Clarification—Issued.

In the G. O. first cited, orders were issued that when an employee of the State Government State Autonomous Body borne on pensionable establishment was allowed to be absorbed in the Government of India Autonomous Body, the service rendered by him under the State Government State Autonomous Body should be allowed to be counted towards persion under the Government of India Autonomous Body irrespective of whether the employee was temporary or permanent in the Government Autonomous Body. The same procedure would be applied in the case of employees of Government of India Autonomous Bodies who were permanently absorbed under the State Government State Autonomous Bodies.

2. The Member-Secretary, State Planning Board, Thiruvanan-thapuram in his letter 3rd cited, has sought clarification whether the service rendered by a State Government Employee previously under Government of India can be reckoned for service weightage for fixation of pay in the revised scale.

3. Government are pleased to clarify that the service rendered by an employee outside the State Government service not included in Appendix III of Annexure III to the G. O. second cited will count only for the limited purpose of pension and not for any other service benefits.
