Sub:—Pension—Family pension—Grant of family pension to parents—Further instructions issued.

As per rules in KSRs, Part III, family pension is payable to parents in the absence of spouse/minor children at the time of death of the employee. The extension of the benefit of family pension is a concession granted subject to certain conditions such as production of proof on the dependency for livelihood upon the deceased Government employee, income within the ceiling, absence of well-placed off springs etc. The eligibility for pension will be determined on the basis of the Income & Eligibility Certificate issued by the Revenue Authorities.

In certain cases, the certificate issued by the Revenue Authorities for sanctioning family pension to parents is not in the prescribed format and does not say whether the applicant is in receipt of any other pension/family pension on the death of any other children/spouse and whether other son/daughters of the applicant are well-placed in life.

Government would therefore insist that the certificate issued by the Revenue Authorities should be in the prescribed format containing all the vital information on the eligibility of the persons concerned.

The District Collectors are hereby instructed to bring the copies of this circular to the notice of all the Tahasildars and Village Officers for strict compliance.
