Economy—Economy in Expenditure—Tours—Foreign Tours of Government Officials and Chief Executives of Public Sector Undertakings—Restrictions issued—Regarding.

With a view to maintain strict economy in expenditure, Government have further decided to enforce some restrictions on the Foreign Tours of Government Officials and Chief Executives of Public Sector Undertakings.

1. All proposals for tours abroad of Government Officials involving expenditure by State Government, will be put up to the Chief Secretary through the Administrative Department in the Secretariat and the Finance Department. Cases agreed to in the Finance Department and recommended by the Chief Secretary will be placed before the Council of Ministers for consideration. Tours to foreign countries will be undertaken only with the prior sanction of the Council. Foreign travel of all Executives and Directors of Public Sector Undertakings including K. S. E. B., K. S. R. T. C. and other similar organisations, Boards, Corporations, Co-operatives, Autonomous Bodies, etc., will have to be referred to Government where it will be placed before the Chief Minister after following the same procedures as suggested for Government officials.
2. Heads and officials of Public Sector Undertakings, Corporations, Co-operatives, Autonomous Bodies, etc., shall reside at Kerala House to the extent possible, whenever they are in New Delhi on official work.
