### ORDER

In the G.Os read as 1<sup>st</sup> 2<sup>nd</sup> and 3<sup>rd</sup> papers above, Government have sanctioned certain allowances/amenities to the police personnel. These benefits with slight modifications were extended to corresponding categories in the Fire Force, Prison, Forest, Excise and Vigilance Departments as per the G.Os read as 4<sup>th</sup> to 8<sup>th</sup> papers above. One of the items of allowance sanctioned to these categories is the special Allowance.

2. In his letters read as 9<sup>th</sup> Paper above, the Inspector General of police has enquired about the classification of the special allowance sanctioned to police personnel and also sought clarification whether the special allowance is admissible during periods of leave and deputation.

3. Government have examined the case in details and are pleased to order that the “Special Allowance” sanctioned to the Personnel and corresponding categories in the Fire Force, Prison, Forest, Excise and Vigilance under Class VI appendix IV K.S.R. and that

the personnel on deputation to other departments, Public Sector under takings etc. will not be entitled to the special allowance. Government also order, as a special case that the 'Special Allowance' will be admissible during periods of Leave.
