**ORDER**

On the recommendations of the commission for Enquiry into Scales of pay and Related Matters, Government issued the following orders regarding –“Project allowance” in para 16 of the G.O.read as first paper above.

“Project allowance will be given only to the staff engaged in projects located in areas where living conditions are difficult and there is lack of amenities. In cases where such an allowance is given on other considerations, the allowance will be withdrawn. The rates of Project Allowance will be as follows:-

Those drawing a salary of Rs. 600 and above	Rs.130/-
Those drawing a salary of Rs. 350 and above but Below Rs. 600	Rs. 120
Those drawing a salary of Rs. 225 and above but Below Rs. 350	Rs.105
Those drawing a salary of Rs. 100 and above but Below Rs.225	Rs. 90
Those drawing a salary below Rs.100/-	Rs. 75

As the above rates take into account hill tract allowance also, those who draw Project allowance will not be allowed separate hill tract allowance.

The benefit of Project allowance will be extended to the staff in Projects undertaken by the Public Health engineering Department also, provided the forms prescribed are satisfied.

Staff belonging to other Departments (Land Acquisition, Staff, staff in schools etc) functioning in the project areas for the benefit of those working in the project will also be granted project Allowance.

Separate orders will issue specifying the units which would be eligible for Project allowance on the above basis”.

2. Government also directed in the Circular dates 7-8-1969 that pending declaration of project units, payment of project allowance/Special Project Allowance will be discontinued in the bills for the month of August payable in September 1969 and thereafter.

3. A Committee of officials , with the First Member, Board of Revenue as its Chairman , was asked to go into the question and report Government the name of the Project Units and the staff eligible for Project allowance, in the light of the report of the pay commission and the orders issued in para 16 of the pay revision G.O.dated 9-6-1969, Government are pleased to order that order that the staff of the following projects having their offices at the places noted against each will be eligible for the Project Allowance at the rates sanctioned in the pay revision G.O.

Such of the staff of the above Projects as were entitled to or in receipt of Project Allowance/Special Project allowance prior to the direction contained in the Circular cited, will be eligible for the Project allowance at the revised rates from the date from which the payment of the allowance was discontinued and in the case of others the allowance is payable from 1-2-1970 ie from the month of February 1970 onwards.

5. Hereafter there will be no separate Special Project Allowance but only Project Allowance.
