Sub:- Schedule of rates revision with effect from 1.7.96

Ref:- G.O.Rt.No.1094/96/PW&T dt. 26.6.96.

...

The Schedule of rates revised with effect from 1.9.92 is in force till now in the Department. Now the schedule of rates has become out dated and it has no bearing on the present labour rates and material costs. The matter was discussed in detail by the Chief Engineer's and Superintending Engineer's of the department and proposals were submitted to Government for revision and appropriate orders.

Government as per order referred above have accepted the proposal for revision of schedule of rates, furnished by the Deputy Chief Engineer, with effect from 1.7.96.

Accordingly the following rates will come into force in the Department from 1.7.1996.

A. Labour

a. The rates of labour as per 1992 Schedule of rates shall be increased by 40% (Forty percent) for civil works and 25% (Twenty five percent) for all electrical works.

B. Hirecharges and conveyance charges.

The rates of hirecharges and conveyance charges shall be increased by 15% (fifteen percent) of the 1992 schedule of rates.

C. Materials.

The material rates shall be increased 30% (Thirty percent) of the 1992 schedule of rates (except for timber and electrical items)

For timber items for which Forest department has recommended rates the same shall be adopted. For teak wood items for which there are no rates of Forest Department, 75% increase shall be allowed over the 1992 Schedule of rates. For other species of timber 25% increase shall be allowed over the 1992 schedule of rates.

For electrical items 25% increase shall be allowed over the 1992 Schedule of rates.

For cement and bitumen the revised B& rates to shall be as follows.

(i) Cement Rs. 2600/MT

(ii) White cement Rs. 9/Kg

(iii) Steel

M.S. rounds Squares. | Rs. 1400/Qtl

M.S. angles, channels flats

Joists Twisted bar (Tor steel)

(iv) M.S. Plate. Rs. 1600/Qtl

(v) Asphalt (bitumen) Rs. 5400/MT

The lumpsum provisions given in the standard data book shall remain the same and no increase shall be allowed for this.

The above changes shall take effect from 1.7.96.
