**ORDER**

In the G.O. read as first paper above Government had accepted a revised Requisition Form and all appointment authorities in the State Government Sector (including quasi Government institutions, Industrial Establishments and Local/Statutory Body Institutions under the control of the State Government) were instructed to use the revised Requisition Form for notifying vacancies to the Employment Exchanges.

The G.O. read as second paper above provides the reservation of 50% of the State Government vacancies filled through Employment Exchanges to priority groups and other 50% to the candidates belonging to the non-priority groups. Communal reservation has also to be maintained by employees for even purely temporary vacancies. The employers have to specify the category of candidates required by the requisition form. In the circumstances cols 4(a) and (b) under the heading “Details of reservation of vacancies” of the requisition form prescribed in G.O.M.S.No.705/64/HLD dated 25-09-1965 are amended as follows:-

- (a) Unreserved (Open competition) Priority Non-Priority
- (b) Reserved for
  - (i) Scheduled Tribes  
Priority  
Non-Priority

- (ii) Scheduled Caste  
Priority  
Non-Priority
- (iii) \* Other Backward Classes  
Priority  
Non-Priority

\* Mention communities wherever necessary

All appointing authorities in the State Government another will incorporate the amendments suitably in the requisition form whenever required. The Superintendent Government Presses will incorporate the amendments new made when the forms are reprinted. A copy of the requisition form incorporating the amendments is forwarded to the Superintendent, Government Presses.
